# FLORIDA INTERNATIONAL UNIVERSITY AD HOC GLOBAL LEARNING CURRICULUM OVERSIGHT COMMITTEE

#### ACADEMIC YEAR 2010-2011FINAL REPORT

## I. OVERVIEW

This AY the committee met on the following dates: June 7, September 29, October 20, November 17, January 24, March 3, April 7, April 28. At the beginning of AY 2010-2011, the committee membership was comprised of Gail Hollander (Chair); Paul Kowert (Secretary); Stephen Lin, Martha Pelaez, and Marilys Nepomechie. As per our policies and procedures, two faculty members were due to be rotated off the committee. However, since one of those positions had just recently been filled, only one person (Paul Kowert) left the committee, to be replaced by Russell Lucas. At the September 29, 2010 meeting, Gail Hollander was re-elected as chair of the committee.

Prior to the beginning of the fall semester, Gail Hollander met with Hilary Landorf to discuss proposals to suggest to the committee to systemize the review process. At the first meeting of fall semester 2010, September 29, the committee agreed that each member of the committee would be the first reader on 3 syllabi per meeting and the second reader on another 3 syllabi (the exact number varying). The two faculty members would then make recommendations to the rest of the committee. This allowed the committee to increase productivity from one or two course packets reviewed per meeting to 15. Packets of their assigned materials were distributed to each committee member for review in ample advance of each meeting. Moreover, electronic versions of all course materials were made available to all committee members so that, prior to voting, every course could be easily reviewed by the entire committee.

Dr. Hollander invited Dr. Tom Breslin to attend the March 3, 2011 meeting to discuss the committee's mandate, its modus operandi, and its future in terms of the process of overseeing Global Learning Curriculum as it is enacted throughout the University. Dr. Breslin noted that the Steering Committee, while discussing its Constitutional review changes, had suggested making the AHGLCOC a subcommittee of the larger Curriculum Committee. After discussion, the AHGLCOC decided this structure would not be functional or desirable and suggested the Steering Committee change the constitution to add the Global Learning Curriculum Oversight Committee as a standing committee. The Committee is especially concerned that in addition to reviewing courses seeking GL designation, there will be ongoing reviews of assessment measures for courses that have been approved and are being taught. The Committee also discussed how to achieve a balance between meaningful review of courses for global learning content and maintaining the principles of academic freedom for faculty to control the content of their courses.

Immediately below is a list of all of the courses that the AHGLCOC has reviewed and approved, the first five during the previous AY. Between June 2010 and June 2011, the AHGLCOC reviewed and approved 69 additional courses. Fifteen of these are in Bulletin 6 and await Faculty Senate Approval. Following this list are the minutes from each AHGLCOC meeting held during AY 2010-2011.

# Minutes of Meeting

June 7, 2010 Faculty Senate Conference Room, 11:00 am - 1:00 pm

In attendance: Gail Hollander (Global & Sociocultural Studies, Arts & Sciences), Paul Kowert (Politics & International Relations, Arts & Sciences), Stephanie Doscher (Associate Director of the Office of Global Learning Initiatives), Marilys Nepomechie (Architecture, Architecture and the Arts), Martha Pelaez (Educational and Psychological Studies, Education). Absent: Stephen Lin (Accounting, Business Administration). Guests: Joann Brown, Dawn Addy, Ron Giachetti, Ben Smith.

Dr. Kowert called the meeting to order after being asked by Dr. Hollander to chair this meeting. The meeting began with a brief note of explanation, by Dr. Kowert and Ms. Doscher, that the meeting was called on relatively short notice in order to present recommendations for 7 pending courses to the Faculty Senate before its June 15 meeting. The meeting agenda was reviewed and approved, and the minutes of the previous meeting were also reviewed and approved without changes.

The committee then turned to its first major agenda item, consideration of seven Global Learning Foundation course proposals:

### 1. "Intercultural Communication"

Dr. Brown was in attendance and briefly described the course. The committee commended Dr. Brown on a proposal for GL designation that was well prepared and a natural fit.

Decision: **Approved**, but with the following suggestions for improvement: (1) that the required readings must include the common core reading (Appiah, "The Case for Contamination"); and (2) that instructors give further thought to how best to assess the "Global Engagement" objective, so that the assessment activity reflects the students' own willingness to engage in global, international, and intercultural problem solving.

#### 2. "Introduction to Labor Studies"

Dr. Addy was in attendance and briefly described the course. The committee commended Dr. Addy on a well-crafted proposal, but spent some time discussing the extent to which the course presented global perspectives on labor.

Decision: **Approved**, but with the following suggestions for improvement: (1) that the required readings must include the common core reading (Appiah, "The Case for Contamination"); (2) that the syllabus should clarify the use of active learning strategies (such as student interviews) in the course; and (3) that the list of course requirements on the syllabus be improved to facilitate student understanding of each graded component, including those used to meet GL objectives.

### 3. "Global Supply Chains and Logistics"

Drs. Giachetti and Smith were in attendance. Dr. Giachetti briefly described the course, and the committee commended Dr. Giachetti and his colleagues on a dramatically improved proposal for GL designation. The committee then discussed the apparently large reading load in the first part of the course. Dr. Smith clarified that only a selection of the listed readings (and chapters) would be assigned to students.

Decision: **Approved**, but with the following suggestion for improvement: that the syllabus should clearly distinguish required and recommended readings, and that the team proposing the course carefully review the assigned readings to ensure that readings assignments are manageable.

# 4. "Technology, Humans, and Society"

The committee expressed the conviction that this course was likely to be a good candidate for GL designation. In general, however, committee members found that the syllabus, as presented, did not clarify sufficient Global Learning content.

Decision: **Suspended**, requiring revisions before resubmission to the Committee. The Committee requests that the following points be addressed: (1) the required readings must include the common core reading (Appiah, "The Case for Contamination"); (2) the syllabus should clearly link reading assignments to the lecture schedule; and (3) the readings should be linked to lectures in a way that clarifies the Global Learning content of the course (i.e., the assignments should deal not only with technologies with an acknowledged global impact, but should also indicate how global perspectives will be taught, how global awareness will be raised, and how global engagement will be achieved).

# 5. "Studies in World Religion"

The committee noted that this course (like "Religion: Analysis and Interpretation, discussed below) is delivered in two ways--classroom and online. The committee discussed the distinction between phenomena (including religion) that occur around the world and those that involve global interactions.

Decision: **Approved**, but with the following suggestions for improvement: (1) that the required readings must include the common core reading (Appiah, "The Case for Contamination"); (2) that instructors should clearly describe on the syllabus the active learning components (such as student site visits) of the course; and (3) that the course description should give some specific attention to religion as a phenomenon of global scope, involving global interactions, and not simply as a phenomenon occurring in various distinct parts of the world.

# 6. "Religion: Analysis and Interpretation"

The committee expressed concern that this course (compared with "Studies in World Religion"), while focusing on aspects of religious analysis that were likely global in scope, did not give clear evidence through a progression of assigned topics that it addressed Global Learning objectives.

Decision: **Suspended**, requiring revisions before resubmission to the Committee. The Committee requests that the following points be addressed: (1) the required readings must include the common core reading (Appiah, "The Case for Contamination"); (2) the syllabus should clearly describe the active learning components (such as student site visits) of the course; and (3) the readings should be linked to lectures in a way that clarifies the Global Learning content of the course (i.e., the progression of topics should clarify how various forms of religious analysis and interpretation are related to GL objectives, indicating how global perspectives will be taught, how global awareness will be raised, and how global engagement will be achieved).

# 7. "World Ethnographies"

The committee noted that this course was another natural candidate for GL designation.

Decision: **Approved**, but with the following suggestions for improvement: (1) that the required readings must include the common core reading (Appiah, "The Case for Contamination"); (2) that instructors should clearly describe on the syllabus the active learning components (such as group activities, mentioned in the matrix) of the course; and (3) that the course description should give some specific attention to how the course speaks across disciplines and intellectual perspectives ethnographically.

The remaining agenda items (three Upper Division GL proposals and approval of Committee Policies and Procedures) were postponed for lack of time.

The meeting adjourned.

### NUR 3668 Nursing Leadership in Global Health

Lucas and Lin discussed this course with Nepomechie's comments and suggested the committee approve subject to the following modifications:

- Global Awareness: Clarify how the assessment activity addresses "interrelatedness."
- Global Perspective: Revise the outcome and the assessment to address multiple perspectives. The current outcome does not stipulate that students need to address multiple perspectives in their leadership plan. The current assessment activity engages the student with only one other perspective, that of the interviewee.
- Global Engagement: Clarify how students will be assessed for their willingness to engage in local, global, international, and/or intercultural problem solving in the context of the scenario.
- Clarify how global learning is addressed in the topic outline.

Pelaez's email comments: I vote in favor of approving condition to making the modifications recommended at yesterday's meeting.

With a majority vote, the course was approved pending the above changes.

### **PCB 4467 Marine Protected Areas**

Lucas and Lin discussed this course and did not find any problems with approving it.

Pelaez's email comments: It has been our committee's practice to request that all syllabi offer a list of required reading material to the students, whether textbooks or journal articles. To be approved, this course should offer such list. The course in my view, needs to be placed within the Global Learning theme more clearly. It would be very helpful to the students and to this committee if the syllabus would include a list (or examples) of global or international marinas already protected. Thus far, the content seems limited and/or constraint to the Caribbean region. I vote to approve this course after it includes modifications suggested here and at yesterday's meeting.

Lucas's email comment: I had voted for approval, but I do not object to Martha's requests.

With a majority vote, the course was approved pending the above changes.

### EML 4905 Senior Design Project

\*Hilary Landorf says that this course should be considered separately from the 1-credit course (EML 4551) above. Because the QEP Curriculum Framework stipulates a two-course GL graduation requirement but DOES NOT stipulate the number of credits required, the EML 4551 course can be used to fulfill the graduation requirement. The committee was satisfied with EML 4551. The committee should now discuss EML 4905 on its own and provide notes for improvement.

Pelaez's email comments: First, the syllabus offers no clear justification or explanation of how the Global Learning objectives will be achieved. In other words, there is no specification of how the structural design, prototype construction, and project, to be presented to industrial board, are connected globally. The proposal does mention an economical analysis with global environmental implications—but the implications are missing. Some examples will help the students understand. A calendar of lectures or schedule connected to the class topics and readings due that day is also missing in the proposal. In addition, the course requirements were no included in the syllabus, nor the grading system, university policies for conduct, nor any general policies like attendance and else. I move not to approve this course and encourage the authors to resubmit a complete proposal.

Lucas's email comment: Martha has moved to not approve this course and encourage the authors to resubmit a complete proposal. Given the different nature of this course from others that we have looked at, I am wondering if this course may require more than email discussion.

It was approved to table this proposal to bulletin 5 and ask for a resubmission of the proposal which addressed the above changes.

#### CCJ 4XXX Human Trafficking

Lucas and Lin discussed this course with Nepomechie's comments and suggested the committee approve subject to the following modifications:

• On the assessment matrix, clarify whether the minimum criteria for success is 75% of all items or only global learning items on the multiple choice exams. Pelaez's email comment: I vote to approve this course subject to the modifications requested by thus committee at yesterday's meeting. With a majority vote, the course was approved pending the above changes.

# NUR 3666 Evidence based nursing and research for global healthcare

Pelaez's email comments: This proposal was well prepared and quite complete. It includes all requirements, policy, evaluation methods and reading. However, it is **still missing or unclear how is the content of this course linked to global learning outcomes and students' competencies.** I will approve subject to providing more information on this gap.

Lucas's email comment: I will concur with Martha's recommendations.

Hollander approved via email.

-The committee noted a lack of global themes, trends, and/or issues that unify the content of the course and merit designation of the course for global learning designation.

- -The committee suggests that the course provide a more extensive survey of theatrical traditions across the world. However, if the course focuses on Western theater, the course should more explicitly explore other cultural influences on Western theater or, conversely, Western theater's influence on other cultures.
- -The committee noted a lack of relatedness between the global learning outcomes and the assessments. For example, the outcomes appear to address higher order thinking skills and performance but the assessments appear to assess lower order knowledge and comprehension.
- -The Global Perspective outcome appears to require students to both demonstrate their skill AND self-assess demonstration of the skill. The committee recommends that the outcome specify that students only be required to demonstrate their skill.
- -The course syllabus does not specify any active learning strategies in the course.

# 2. AFA 4372: Race, Gender and Sexuality in Hip Hop

### **Approve Pending Revisions**

- -Replace the SLOs in the matrix with those in the syllabus. The syllabus SLOs are more specific.
- -Clarify the meaning of the minimum criterion for success on the Global Engagement outcome.
- -The committee suggests that a minimum use of the course shell of twice a week be made mandatory, rather than suggested. This will be attendance and is also evidence of the active learning strategies of the course.
- -The committee suggests that the syllabus list public resources for computer access rather than warning students against taking the course if they have difficulty with online access. The committee suggests that the syllabus also make clear that it is the student's responsibility to locate and utilize the available public resources if they are needed.
